- my opinion of this book was that it lacked the detail and spirit that could be found in other Wheel Of Time books.
- As opposed to most other reviewers, I seem to have a middle-ground opinion of this book. To me, Lord of Chaos was a great disappointment; the momentum of the plot, up to that time admirably maintained, faltered almost to a stop. This book began to recover that momentum, though not quite to the previous level yet. However, the next book in the series promises to get back up to the usual high quality level. Overall, the series has had involving plot, and good characterization. The impact of the story and characters was greater toward the start of the series, I think, but is still there. It is not nearly as powerful, however, as Tolkien's climax, or especially as the first two books of the Sword of Truth series (which is exceptional for emotional effectiveness). I look forward to the next book in the series. (Personally, I'm waiting for Mazrim Taim to be "unmasked".)
