Maximos explains the role the Church has played for close to 2000 years as a spiritual hospital. Using this metaphor, the monasteries serve as the ICU for that hospital. Eastern Christianity is a hidden gem in this world and this book is a very good introduction to those who have little knowledge of Orthodox spirituality. I guarantee it will leave you wanting to learn more.
