- This is my seven year old's favourite book. It is not a good read aloud, but perfect for a good reader to curl up with. Dahl's adult characters are mainly the usual grotesques and Matilda is a joy to read. I love the way Dahl never compromises. He writes tension. And scary scenes. Plot is always well paced. Vocabulary is challenging enough. My daughter keeps a notebook for jotting down unknown vocabulary - albeit pronunciation or meaning! Realistically, this would be unsuitable for under sevens - as the

unknown vocab would be way too much! Now a classic - but do yourself a favour - do not use it as a read aloud at a young age. It should be savored as a juicy morsel when reading to oneself. Suitability 7- 12 years.
