REVIEW OF BUSINESS LAW 9TH EDITION QUIZZES

- I purchased the 1979 edition of Hazlitt's book as a MBA candidate at Pepperdine University. My professor, the erudite and sharp minded Dr. George Reisman, wanted to instill in his students the fundamental principle of liberty and how government attempted to disrupt and eradicate that liberty at every

opportunity. Intervention was its means and totalitarianism was its method. Hazlitt is no exception when it comes to upholding liberty. His book attests to the vitality of his work. The book's rankings on Amazon demonstrates how oppressed people seek for answers to fend off the oppressors and their interventionist policies through a corrupt government. He begins the work at the place Ken Starr did in a lecture I attended in which he reviewed his prosecutorial experience with former President Clinton: the broken window. There are striking parallels between the economic principle and the moral principle that Starr applied. Both involved the impact of vandalism in a corrupt society. The two vandels existed in separate segments of

society, but the net effect was the same: the destruction of long term value that may not be visible to the naked eye. One was theft of private property through its destruction (the broken window) and the other the theft of societal morals through political corruption. One might ask, "How in the world can you make this parallel?" Easy. Hazlitt argues from the fallacy of destruction. When destruction occurs in any area of society, whether in economics or politics, part of society gets destroyed. He argues that economists who argue for the destructiveness of war see it as a good thing when the opposite is true. When destruction occurs, it wipes out capital, and when that happens, wealth declines. The same is true in Clinton's case, except the capital of a moral society

declined (and it continues to do so thanks to an immoral president). Adam Smith makes it clear that economics and morality work hand in hand. Hazlitt confirms this. The other part of destruction is when the government intervenes through heavy taxation and regulation. It performs a similar theft of capital by converting capital into consumption (i.e., public works projects) and stifles the growth of capital, productivity, and the economy. Hazlitt wrote his first edition just after the destructive reign of Roosevelt who presided over the greatest destructive measures in US history with his heavy taxation, tariffs, deficit spending, and regulations. We saw the longest capital destroying Depression in modern history followed by one of the most destructive

was this nation's every experienced that sucked capital out of the economy to feed the war through deficit financing. Hazlitt covers both of these types of destruction to the economy successfully. While it appears that war creates capital, this is deceitful. All war does is shift capital from other industries toward the industries that support the war. A further aggravation of the economy was rationing. With the shifting of capital toward consumption and destruction, rationing of scarce supplies occurred, and guess who was in charge of it? That's right! The government. The result of rationing industries from where capital got shifted to support war industries had their capital stolen, thereby leading to rationing of what was left over in those industries. As these war industries

absorbed capital for producing war equipment that gets destroyed, there is insufficient capital reinvested. Consequently, the entire economy suffered. Then Hazlitt gets into a topic that burns hot today - picking winners and losers among industries and companies. Hazlitt observed the same problem then as exists now with the Obama administration: propping up industries (banks, auto, etc.) at the expense of taxpayers (both individuals and companies). The result is corporate cronyism and corruption. This is how economics and morality get married. In essence, Obama is no different from Clinton in destroying the moral fiber of our nation through the reallocation of wealth and its destruction while he does it. Hazlitt saw that almost 80 years ago

and warned us about it. Those who argue against Hazlitt and his economics are really short-sighted in not being able to see all sides of the economic picture. They miss the point of the very simple but powerful illustration Hazlitt provides at the beginning about the broken window. They see only the consumption side (the loss and new replacement that makes it appear that nothing happened) and not the capital side (the siphoning off of capital through destruction so that eventual capital is lost). Hazlitt points out this ignorance, which makes his message long lasting and popular. Free people do not like to be controlled whether by government, unions (which Hazlitt also addresses), or vandals. All three of these entities not only destroy or reduce capital but also the moral

principles behind the creation of capital. They produce nothing because that is not their purpose. Their purpose is destruction and control, the opposite of liberty, moral sentiments (Adam Smith), and productivity that leads to a vibrant economy.

- Patricia Cornwell's books are nothing short of a master-piece, especially the novel, From Potter's Field. I could not put the book down. Following Dr. Kay Scarpetta through the tremendous search of finding the identity of a young

women who's body was found naked and frozen in Central Park. Then finding out the actual identity of the woman and her relationship with the killer was amazing. Patricia Cornwell's books always have the best, most intriguing characters. For example, the physco-pathic killer, Gault, was such a master-mind at what he did. The way you read a book, not being able to sit still with untameable anticipation of what will happen next, is the way every Patricia Cornwell's books will make you feel. I would recommend this book to anyone! :-)
