GOD" as I turn the pages. I'm waiting to be wrapped up in the fitful panic of the characters I just spent the first half of the book being introduced to. But, I tell you, it never happens. The characters seem to feel all sorts of emotions, but the writing never invoked it in me. I mean, hearing the narrator tell me how frightened and freaked out the characters were is NOT the same thing as the narrator spending time to describe something to me that might freak ME out. I was an outsider. It seemed like the characters were poorly motivated to feel what they felt, since the author never seemed to stop long enough to try to make *me* feel anything. I think this book ends up being nothing more than a shallow, superficial action-adventure story gilded with just the faintest glint of science fiction and psychological drama. If that sort of thing appeals to you, then "Life Form" will too.
