Explanations are given in endnotes and requires some page flipping, but at least provides it for those who are interested. It would have been nice to see more maps and photos, but there is one map included. The only thing I missed was that they didn't include an Afterword like Covey's had. I look forward though to other books from this series dealing with the conquest.
