This is why the pilgrims are never seen leaving Canterbury. In all, the tales tell a very strong moral tale. Nearly every line of this wonderful work can be interpreted with a religious overtone and it is no doubt that Chaucer intended for it to be this way. In closing I would like to make reference to a review I read on this page. The short story for in no way came out of this work. The development of the short story can only be attributed Edgar Allan Poe. To suggest that the short story evolved from this would be a grave error. That aside this is a wonderful tale on the surface level and a morally deep tale if you chose to read into it.
