- I purchased the Oxford Worlds Classics version of this book, amounting to over 1100 pages thinking I'd never finish this book. A friend told me how great the book was after the movie came out, and said unabridged was the only way to go. I figured I would give it a try, and I finished the book over a period of time. I was definitely surprised at how much the book kept me on my feet. I have not read many 1000+ page books, and this has to be my favorite. The story of Edmond Dantes' revenge on the people who imprisoned him is a true classic. One would figure that a man who has been locked away for 16 years for something he didn't

do would come back with violent intentions, but Dantes does not. He keeps his cool, comes across a huge fortune and over time has truly obtained his revenge. A lot of death occurs in the book, but not by the hands of Dantes. Misfortune strikes each of the people who took everything from Dantes, and each time he reveals his identity to one of them, the suspense is very high. This book kept me on the edge of my seat for a long time, and I enjoyed every page of it. If you have the time to devote a few chapters of this book a day, by all means get it. It will remain a classic forever, and will hold a spot as one of the best pieces of French literature ever written.

- The book provides a good overview of information warfare. It is divided into three sections, the introduction, offensive information warfare and finally defensive information warfare. Numerous topics are covered. The author is clearly an expert in security and manages to touch upon all the major information

security topics. The main strength of the book is the breadth of topic selection. By the time you have reached the end of the book, you will have at least a passing acquaintance with all important information security topics. The book is very well referenced and is written in an easy to read style. The enormous topic selection means that no topic is treated in any particular depth. This means that you'll get to know something about everything, but unfortunately you won't develop an intimate understanding of any of the topics covered. At times I received the impression that the book was simply a collection of anecdotes. Some parts of the book resembled sensationalistic journalism and, four years after it was written, many parts of the book are out of date. I would recommend this book to anyone looking for a broad overview of information security. Its scatter gun approach means that you'll hit all of the topics but won't develop a true understanding of the underlying mechanisms involved.
