- After seeing the movie several times, decided I should read this classic. I'm surprised I never have read it before. It is wonderfully written!
- First let me begin by stating that I am not the author of this book. There's not much that I can add to the reviews which have been already written about Mr. Fromkin's book, other than to say that if you want to gain an understanding of the problems which confront that area, this book is a good place to start. Certainly it

is a cautionary tale for any country that decides to involve itself in that area of the world. What was surprising to me was how many of the forces which presently plague the Middle East (Islamic fundamentalism for example) were in existence and creating problems back in 1922! We tend to think that this is a recent phenomenon created by Osama bin Laden and his followers. Fromkin points out however that the Wahhabi Sect, the kind of Islam that bin Laden and the Saudi royal family follow, originated in 18th century Arabia. The most important conclusion which I drew from this book, is that the Middle East is no place to intervene in if you are ignorant about the history of the region and its people.
