However, experimental data indicate that many characteristics implemented to improve efficiency in such systems are linked to these capacities. This implies that when they are present it is because they are essential to the desired performance improvement. Moreover, since the goal is not to imitate human behavior, some of these structural characteristics are different from those displayed by the neurons of the human brain - suggesting that we are at the threshold of a new scientific field, artificial cognition, which formalizes methods for giving cognitive capabilities to artificial entities through the full use of the computational power of machines.

The following chapters address Strategic Decision Making and provide a preliminary agenda for any company wishing to explore the methods in greater detail. Chapter 11 brings chaos theory down to a common, personal level, and explains the implications for certain specific jobs ranging from sales representatives to marriage counselors. The final chapter readdresses the concept of free will and includes an insightful exercise and conversation.
